There are many reasons why you might need to store furniture and effects: between moving houses, during a temporary job posting, while renovations or repairs to your house are carried out, or simply due to lack of space in your home. Whatever the reason, if you need to store some of your household goods for a few days, weeks, or indefinitely, you can rely on P.P. Removals Ltd to help you out.

How it works

On the day of your removal our staff will pack your possessions into industry standard wooden containers. Depending on the quantity of your possessions, this packing will either take place at your property, or back at our facility. You will receive an inventory of your possessions, which you will be asked to sign to verify its accuracy.



The containers are stored at our large, secure, **indoor**, insured, insulated facility. Alarmed, with CCTV and staffed to provide maximum security for your possessions.

As a member of the British Association of Removers, you can be confident that our storage facility is subject to regular scrutiny and regulation, and that our Terms and Conditions are industry standard.

You may or may not know how long your possessions will be in storage. Don't worry! We invoice four weekly, but we charge by the week, so any over payment can be refunded. We need as much notice as possible of your intended date to come out of store.

This storage solution is not suitable for items which need to be accessed frequently during the period of storage. If you do need that kind of access, ask about our self store units. If however, you are likely to need access once or twice, or you have unexpected need to access some of your possessions, there is a minimum charge per container handled.

We aim to combine professionalism with a friendly approach. After all, moving or storing are big decisions - help and advice are all part of the service. We also understand that flexibility is often important, so if you have a specific storage need we can work together to achieve the desired result.

Charges and terms of payment

Storage charges are charged four weeks in advance and are subject to VAT. We will charge you for packing, collecting and placing your goods into store. There will be an extra removal charge when the goods are delivered to your new home. We will also charge if you need access to your stored goods. Ask about setting up a standing order or regular credit card payment. Should a customer fall into arrears, no access to storage will be granted until payment has cleared in our bank. Storage will not be released unless outstanding invoices have been paid.

Prohibited goods

1. Explosives

e.g. Fire extinguishers
Aerosol cans
Gas cylinders
Munitions
Fireworks

2. Flammables

e.g. Paints
Matches
White spirit/thinners
Fuel cans
Cleaning products

Any machinery should be emptied of all fuel (eg. mowers, strimmers)

3. Firearms and ammunition

Are not legally permitted

4. Food

Perishable items should not be stored as they attract rodents. Tinned/sealed or bottled items are permitted

5. Plants

Garden planters, pots, tubs etc, can be stored. We recommend they are emptied and cleaned. House/garden plants can be stored at extra cost

6. Refrigerators/freezers

Normally refrigerators should be emptied and the freezer compartment defrosted. But we may store with contents at extra cost

7. Livestock

No pets (obvious reasons)

These notes are for your guidance, should you require any further information we will be pleased to advise you.

PLEASE NOTE: IF THESE ITEMS ARE KNOWINGLY PACKED IT WILL RESULT IN INVALIDATING YOUR CONTRACT AND LEAVING YOU OPEN TO PROSECUTION IN THE EVENT OF FIRE, CONTAMINATION, ETC.



Our promise to you . . .

Liability for loss or damage to your goods

Four of the clauses in our Terms and Conditions relate to our liability for loss or damage to your goods during the course of work we are contracting to do for you. These are (in abbreviated form):

4. Our responsibility

4.1 It is our responsibility to deliver your goods to you, or produce them for your collection, undamaged. By "undamaged" we mean in the same condition as they were in at the time when they were packed or otherwise made ready for transportation and/or storage.

4.2 In the event that we have undertaken to pack the goods, or otherwise make them ready for transportation and/or storage, it is our responsibility to deliver them to you, or produce them for your collection, undamaged. Again, by "undamaged" we mean in the same condition as they were in immediately prior to being packed/made ready for transportation or storage.
